## Section 5. Fire-fighting measures

### Personal precautions, protective equipment and emergency procedures

### Methods and materials for containment and cleaning up

**Small spill** : Stop leak if without risk. Move containers from spill area. Dilute with water and mop up if water-soluble. Alternatively, or if water-insoluble, absorb with an inert dry material and place in an appropriate waste disposal container. Dispose of via a licensed waste disposal contractor.

**Large spill** : Stop leak if without risk. Move containers from spill area. Prevent entry into sewers, water courses, basements or confined areas. ## Section 7. Handling and storage

### Precautions for safe handling

**Protective measures** : Keep container tightly closed. Avoid contact with skin and eyes. Always keep in containers made from the same material as the original one. Avoid inhalation of vapor, spray or mist. Put on appropriate personal protective equipment (see Section 8). Never use pressure to empty. Container is not a pressure vessel. Comply with the health and safety at work laws.

**Advice on general occupational hygiene** : Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. - Appropriate engineering controls** : Good general ventilation should be sufficient to control worker exposure to airborne contaminants.

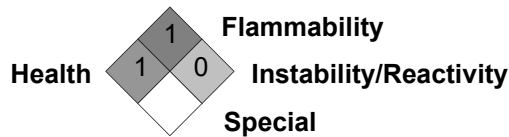
